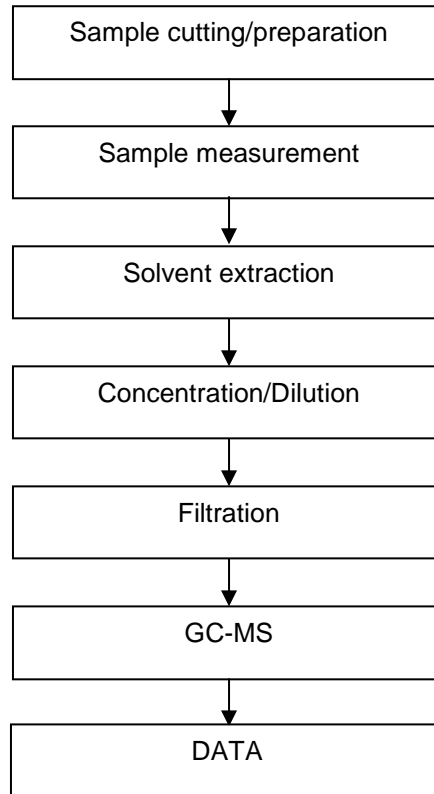

DMF (Dimethyl fumarate) Testing Flow Chart



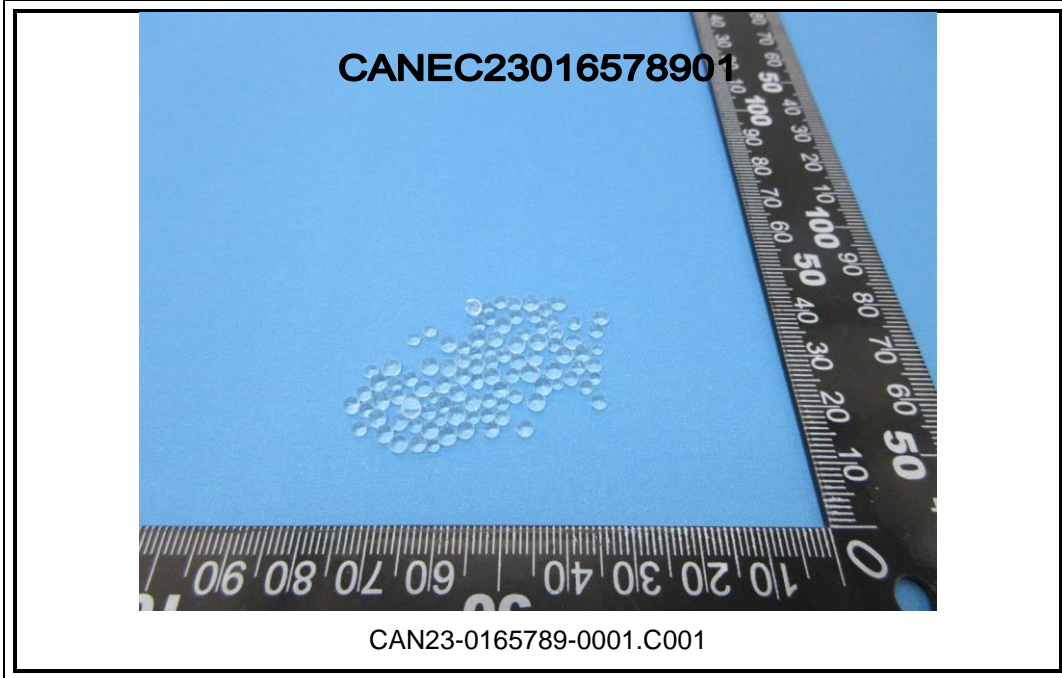
